A. Consider a Resolution awarding a contract to and authorizing and directing the City Manager or his designee to execute any necessary documents with Reynolds and Kay, LTD, of Tyler, Texas in the amount of \$403,930.25 for construction of the Loop 281 and Nealy Way Traffic Signal Intersection Improvements Project –

Rolin McPhee, P.E., Director of Public Works was present and requested the Council to consider the approval of a Resolution awarding a contract in the amount of \$403,930.25 to Reynolds & Kay, LTD of Tyler, TX for the construction of the referenced project. The following bids were opened on December 17, 2020:

The scope includes the installation of a four way traffic signal at the intersection of Loop 281 and Nealy Way and the construction of an additional left turn lane.

Johnson & Pace Inc. has examined the bids and the qualifications of the low bidder, and recommends award of the contract to Reynolds & Kay, LTD. of Tyler, TX in the amount of \$403,930.25. Staff concurs with their recommendation.

J.P. Steelman, Fire Chief was present and requested the Council to consider the approval of a Resolution adopting and allowing the City of Longview to enter into a cooperative purchasing agreement with the City of Midlothian, Texas. The City of Midlothian competitively bid a contract for EMS Supplies for their Fire Department. The bid was awarded to Boundtree Medical, LLC. out of Dublin, OH. The Longview EMS Section wishes to utilize this contract. By entering into a cooperative purchasing agreement with the City of Midlothian, the City of Longview will be able to use the EMS supplies contract obtained by the City of Midlothian. Use of this cooperative purchasing contract will satisfy the competitive bidding laws for the purchase of said EMS supplies for the EMS Section.

Contracts that the City of Longview may utilize in the future with the City of Midlothian are pre-bid and therefore meet all of the competitive purchasing laws.

FUTURE LAND USE:

The Comprehensive Plan designates this area for Low Density Residential (LDR).

STAFF COMMENTS:

The applicant is requesting a rezone for Lot 5, Block "A" of Sunny Side Estates Unit 3 from Heavy Commercial (C) to Single Family (SF-5) Zoning District located at 103 St Clair Drive. The applicant would like to subdivide the lot into two and build a single family home on each lot.

St Clair Drive is classified as a local roadway and is maintained by the City of Longview. Residential uses are appropriate along this roadway.

Staff finds the proposed zoning change is consistent with future land use map and surrounding uses.

STAFF RECOMMENDATION:

The Planning and Zoning Commission (9-0) and Staff recommend approval for this request.

FUTURE LAND USE:

The Comprehensive Plan designates this area for Office (OFF).

STAFF COMMENTS:

The applicant is requesting a rezone for Lot 2, Block One of West View Villas from Office (O) to Single Family (SF-4) Zoning District located at 4350 McCann Road. The applicant would like to further subdivide the lot and building single family homes.

This portion of McCann Road is classified as a Collector road. Collector roads provide for the collection and distribution of traffic between arterial and local streets. This type of development is appropriate along this roadway, as long as access management is followed. For this development, the applicant will be required to share a driveway to minimize the number of driveways along McCann Road.

Staff finds the proposed zoning change is consistent with surrounding uses.

STAFF RECOMMENDATION:

The Planning and Zoning Commission (9-0) and Staff recommends approval for this request.
