Purpose of this Report

The Longview Metropolitan Planning Organization (MPO) is required by the Moving Ahead for Progress (MAP-21) Act "to publish or otherwise make available an annual listing of projects, including investments in pedestrian walkways and bicycle transportation facilities, for which federal funds have been obligated during the previous fiscal year. The listing shall be consistent with the funding categories identified in the Longview Transportation Improvement Program." Obligated projects in this report are broken down in to five categories; highways, transit, bicycle, pedestrian, and other grouped projects. This report provides an overview of the transportation planning and programming process and the resulting federal funding obligation of the Transportation Improvement Program (TIP).

This report lists all projects which were federally obligated in the 2015 fiscal year (October 1, 2014 – September 30, 2015). An obligation is the federal government's commitment to pay its fair share of the project cost. This obligation happens at the time where the project is executed and the State or Grantee requests the funds. For Federal Transit Administration projects (FTA), obligation occurs when the FTA grant is awarded. In summary, an obligated project is one that has been approved by the federal government for reimbursement.

(Projects contained in the Annual Listing of Projects may not have been initiated or completed in the fiscal year)

Metropolitan Planning Organization (MPO) Information

The Longview Metropolitan Planning Organization (MPO), acting through the City of Longview Planning Department and coordinating with the Texas Department of Transportation, is responsible for coordinated, comprehensive, and continuing transportation planning for all modes of surface transportation in the Longview Metropolitan Area. The Longview MPO serves the cities of Longview, White Oak and Gladewater, and parts of Gregg, Harrison and Upshur Counties. As an urbanized area with a population of over 50,000, the City of Longview was designated as an MPO by the Governor in the 1988. The MPO is governed by elected and non-elected officials from the area.

The Longview MPO's offices are located in the City of Longview Development Services Building, 410 S. High St., Longview, Texas 75601.
